WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01 12 2014

- AND WHEREAS, the recognition was granted by NRC to Swami Vivekanand Subharati University, Meerut, Plot No.-1628 & 1629, Street No.- Meerut, Viii.- Maliyana, Post Office- Maliyana, Tehsil- Meerut, Town City- Meerut, District. Meerut, Pin Code- 2500015, Uttar Pradesh for M.Ed. Course vide order no. NRC/NCTE/UP-3118/198th Meeting/2012/20250 dated 03.05.2012 with an annual intake of 35 seats from the academic session 2012-2013:
- 3. AND WHEREAS, the said institution has by affidavit consented to come under New Regulations which require

NRC/NCTE/F-7/UP-3108/164th Meeting/2010/27899-27905 dated 21.09.2010 with an annual intake of 35 seats from the academic session 2010-2011 for conducting M.Ed. programme of two years duration with an annual intake of 50 for one basic units of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
